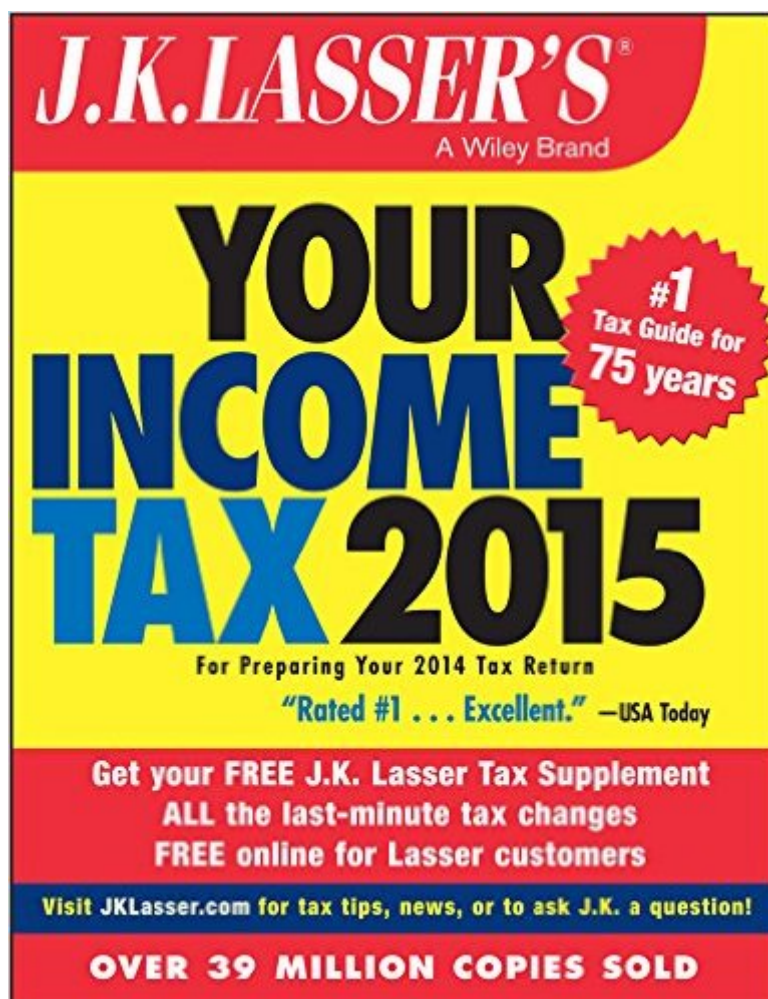

Both the CPA firm I co-locate with and I order this book every year for two purposes: quick, simple reference and a source to provide clients with a discussion of issues of concern to them. We use our tax library for more involved questions. When client's call with generic questions, we scan relevant pages and e-mail the information to clients rather than try to summarize. At the end of the year, the books are worn out and have torn pages. For the layman, this is a lot of well written information which goes beyond the help screens on popular tax preparation programs.

This is a must have for anyone that files a income tax return. Even those of you who hire a CPA it never hurts to study the IRS rules to protect yourself. Keep in mind not matter who prepares your return you are responsible for the correctness of the return and you alone will be fined for errors.

As of mid-December 2014, this could be described as just the "preview edition", as there was little if any information regarding the Affordable Care Act instructions and forms. Of course, the IRS has only released draft instructions back in September, and preliminary forms, which are not in the book. Also, in my Kindle App on Android tablet, I could not activate a table of contents nor an index, so I had to page through each page, or touch chapter topic links to get through the book as quickly as possible. So, I will be patiently waiting for Congress, the IRS to finalize most forms and instructions, and JKL's e-supplements for more complete information. I think in the future, I may just wait for the paper copy to be published.

Having done my own taxes for the last 20 or more years using a book such as this, one would think I would give a positive review. This year I realized how ludicrous this so called publication is. Do you want to read hundreds of pages about having seeing-eye dog. while losing all your investments through theft , as you maintain a part-time residence in NY City with certain qualifying children? If your situation is that complicated, you need a CPA. Otherwise, standard tax software should suffice and this book is an anachronism.

The first year I was married, we had someone do our taxes and I was amazed at whatwe had to

pay. The next year, I bought a JK Lasser's Income Tax book and saved usa bundle. I've been using them ever since - 46 yrs! I believe we all have an obligation to pay our taxes and support government services but...it's almost un-American to pay more than we have to. JK Lasser's Income Tax books, whether the professional edition or the paperback edition, each year highlight new tax law changes, explain the rules & regulations and explain all deductions available under the current law. They are also a great reference if you have any questions about a given rule, what to report as income, how to fill out a form or figure something out. These books cite tax law, tax law court rulings and have helpful advice and strategies for lowering your tax bill not only during the current FIT season but to plan for next year as well in easy to understand language.
